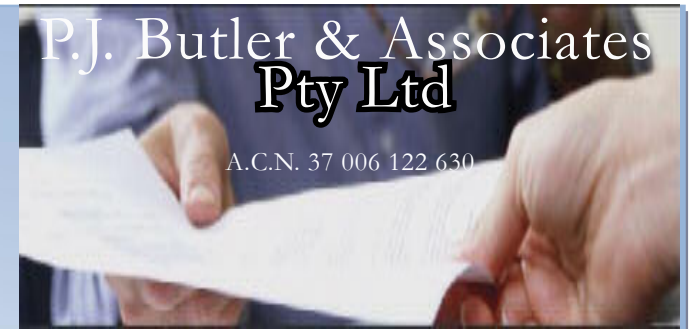

# Process Serving

*Are your Investigators and Process Servers too slow, expensive and failing to meet your expectations?*

# Skiptrace Reports



This type of report can be undertaken when you are endeavouring to locate a Defendant, Debtor, Witness, etc.



Initially we will attend their last known address and make enquiries with the current occupants and also neighbours with the latter often being the best source for gathering helpful information concerning their new address, area where they might have moved to, occupation, employment details or even social activities (i.e. Sporting Clubs, etc) that they might have involvement in.

Further follow-up enquiries are then undertaken with Landlords, Property Owners and/or Managing Estate Agents, etc.

The results of these are then collated together and various searches undertaken for the purpose of locating their current whereabouts.

*Do You Need To Locate A Defendant, Debtor, Witness, etc?*

The information is also used to try and identify other members of family or friends with whom they might have resided with at the last known address, as these persons may in some instances be easier to locate.



# Field Calls
